As a result, Mr. Butenschoen is hereby issued a full suspension of his New Jersey Racing Commission license for a period of fifteen (15) days, and fined the sum of five-hundred (\$500.00) dollars. Said suspension shall begin on November 8, 2020 and run through November 22, 2020 inclusive.
