## **POSITIVE TEST- POST RACE**

PA Code Title 7-401.2(1),401.41,401.42,401.45,401.46,205.33(2). Mr. Rickert was the trainer of record for MUSCLES ON FIRE in the 5th Qualifying Race at The Meadows on August 27, 2020. Post race analysis of sample 353950 showed the presence of CLENBUTEROL (Class 3B), which was confirmed by split sample. MUSCLES ON FIRE finished 2nd and is placed 5th. Mr. Rickert is hereby issued a \$500 fine and a 15 day full suspension of his license as of November 28, 2020 through and including December 12, 2020. MUSCLES ON FIRE is placed on the Steward's List for 30 days as of November 28th and must re-qualify. Any trainer transfers of horses in his care must be approved by the Judges at The Meadows. During the term of suspension, Mr. Rickert is ruled off all grounds under the jurisdiction of the Commission. As this was a qualifying race, there is no purse to return. Mr. Rickert has 10 days to appeal this decision to the PSHRC, Bureau of Standardbred Racing.
