## **POSITIVE TEST- POST RACE**

J. Sam Banks II being the Trainer of record on the mare B N HOPEFUL and attending Judges Hearing (2pm 12/30/2020) is fined \$1,000 for a positive test (Dexamethasone). Dover Downs blood and urine sample # S-4545 contained approximately 950 picograms per milliliter of plasma. BN HOPEFUL was disgualified from 1st and placed 7th (see DHRC rules: 8.3.3.1.2; 8.3.3.3; 8.3.3.3.2). There will be a purse redistribution. All fines to be paid within 10 days of receipt of ruling.

# **POSITIVE TEST- POST RACE**

Blood sample #872243 collected at Northfield Park on 8/12/20 from the horse Peter's Royalty was found to contain Tripelennamine. All purse money must be returned for redistribution (\$8,750.00). O.S.R.C.-3769-18-01(B)(1),(10),(13),(15),(16)&(17) 18-02 18-99 If the fine is not paid to the judges by 9/26/20 you may be suspended and or license revoked by the commission. Mr. Beaver is barred from all grounds governed by the OSRC during his suspension. Any horses under his care that he wants to transfer to another owner or trainer must be approved by the judges or the OSRC.

Status as of 1/5/2021 - Subsequent Ruling - Mr. Beaver has dropped his appeal of rulings SCD-20-74 and NFLD-2020-167 and the penalties have been amended. All purse money must be returned for redistribution (\$23,000.00) to Scioto Downs and (\$8,750.00) to Northfield Park. O.S.R.C.-3769-3769-18-01(B)(10)&(13) 18-02 18-99 Mr. Beaver is barred from all grounds governed by the OSRC during his suspension. Any horses under his care that he wants to transfer to another owner or trainer must be approved by the judges or the OSRC. If the fine is not paid to the judges by 1/12/21 you may be suspended and or license revoked by the commission. If the purse money is not returned by 1/12/21 the owners shall stand suspended until all purse money has been returned to the permit holder. Horses owned wholly or in part by the owners shall also be suspended and are not transferable until the purse money is returned.
