LOW OR EXCESS LEVEL OF AUTHORIZED MEDICATION

Miami Valley Raceway O.S.R.C. 3769-18-01.(B)(1)(b) Trainer Mike Polhamus is hereby fined two-hundred fifty-dollars (\$250.00) for violation of Ohio State Racing Commission Rule 3769-18-01.(B)(1)(b). Blood Sample #899819 taken from the horse Rose Run Vindicate and tested by the Analytical Toxicology Laboratory at the Ohio Department of Agriculture on January 22, 2021 showed a concentration of Flunixin at 53 +/- 7 ng/mL, which exceeds the O.S.R.C. regulatory threshold of 20 ng/ml. If the fine is not paid to the judges by 2/9/2021 you may be suspended and or license revoked by the O.S.R.C

POSITIVE TEST- POST RACE

Blood sample #878584 collected at the Delaware County Fair on 9/23/20 from the horse Dontforgetlittlman was found to contain dimethyl sulfoxide (DMSO) at a concentration of 11.1+-0.1 micrograms per milliliter of plasma. This exceeds the Regulatory Threshold of 10 micrograms per milliliter adopted by the OSRC. All purse money must be returned for

redistribution (\$8,750.00). O.S.R.C.-3769-18-01(A)(2) 18-01(B)(1)(10)(13)(15)(16)&(17) 18-02 18-99 If the fine is not paid to the judges by 10/24/20 you may be suspended and or license revoked by the commission.
