Miami Valley Raceway O.S.R.C. 3769-18-01.(B)(1)(b) Trainer Mike Polhamus is hereby fined two-hundred fifty-dollars (\$250.00) for violation of Ohio State Racing Commission Rule 3769-18-01.(B)(1)(b). Blood Sample #899819 taken from the horse Rose Run Vindicate and tested by the Analytical Toxicology Laboratory at the Ohio Department of Agriculture on January 22, 2021 showed a concentration of Flunixin at 53 +/- 7 ng/mL, which exceeds the O.S.R.C. regulatory threshold of 20 ng/ml.
