Mr. Robinson is hereby suspended for a full ninety days, from February 2, 2021 to May 2, 2021. During his suspension Mr.Robinson is denied the use and priviliges of all grounds sanctioned by the OSRC. All horses owned and/or trained by him are suspended and may only be transfered by the judges at Dayton Raceway and/or the OSRC in accordance to its policy.
