POSITIVE TEST- PRE RACE

Brian Callahan being "trainer of record" on blood sample #36981 taken on 2/24/21 from "MITTANY NICOLE" was found to contain a Total Carbon Dioxide (TCO2) concentration of 42.1+/- 0.89 mmol/L. This is Mr. Callahan's second TCO2 offence within 16 months. Therefore, a penalty of \$1000 fine and 60-day suspension from training has been issued. (3/11/2021 – 1/31/2020). During this suspension, he and all horses trained by him are barred from the grounds, under the jurisdiction of the Maryland Racing Commission. Any transfer of horses during this suspension must be approved by the Judges at Rosecroft Raceway or MRC. "MITTANY NICOLE" is barred from racing for 30 days before being eligible to race. "MITTANY NICOLE" finished 3rd and was disqualified, placed 9th. All purse monies must be returned within 72 hours of the ruling. COMAR 09.10.02 Addendum A-11 MMV 4pts
