#### POSITIVE TEST- POST RACE

Dayton Raceway Trainer Matt Amann is hereby fined the sum of five hundred dollars (\$500.00) and issued a fifteen day full suspension from January 18, 2021 through February 1, 2021 for violation of O.S.R.C. Rule 3769-18.01(A)(2), 3769-18-01(B)(1),3769-18-01(B)(15-16-17),3769-18-02 & 3769-18-99. In addition purse money of three thousand six hundred twenty five dollars (\$3,625.00) must be returned to Dayton Raceway. Blood Sample #883738 on the horse Barley Nation tested by the Analytical Toxicology Laboratory at the Ohio Department of Agriculture on December 21, 2020 revealed a presence of Gabapentin, an anticonvulsant. During his suspension Mr. Amann is denied the use and privileges of all grounds sanctioned by the OSRC. All horses trained by Mr. Amann are suspended and may only be transferred with permission from the judges at Dayton Raceway or the executive director at the OSRC. If the fine is not paid and purse is not returned to the judges by 1/28/2021 you may be suspended or

Status as of 3/20/2021 - Subsequent Ruling - Mr. Amann has dropped his appeal of ruling DTN-20-33 and the penalties have been amended. All purse money must be returned for redistribution (\$3,625) to Dayton Raceway O.S.R.C.-3769-3769-18-01(B)(10)&(13) 18-02 18-99 Mr. Amann is barred from all grounds governed by the OSRC during his suspension. Any horses under his care that he wants to transfer to another owner or trainer must be approved by the judges or the OSRC. If the fine is not paid to the judges by 4/8/21 you may be suspended and or license revoked by the commission. If the purse money is not returned by 4/8/21 the owners shall stand suspended until all purse money has been returned to the permit holder. Horses owned wholly or in part by the owners shall also be suspended and are not transferable until the purse money is returned.
