Following this race, "Big Smoove" was required to submit a blood sample for analysis. A report from Industrial Laboratories identified the presence of Flunixin above the allowable limits. This is in direct violation of N.J.A.C. 13:71-23.8. Mr. Hernandez has waived his right to send a split sample to an independent laboratory for testing as well as his right to a hearing before the Board of Judges and is hereby issued a full suspension of his New Jersey Racing Commission license for a period of fifteen (15) days and a fine of five-hundred (\$500.00) dollars. Said suspension shall begin on May 10, 2021 and run through May 24, 2021, inclusive. During the period of suspension, Mr. Hernandez is denied access to all grounds that are under the
