### **POSITIVE TEST- POST RACE**

MGCB Ruling 7332 - As a result of a prehearing conference held June 16, 2021, the parties agreed to settle this matter in the following manner: 1. Three (3) month suspension of trainer`s license from June 1, 2021 to September 1, 2021. 2. Remaining three (3) month suspension of trainer`s license to be held in abeyance through December 31, 2021. 3. \$1,000.00 of the fine will be paid within ten (10) days. 4. CHAPTER 3 SECTION 5 #3 A-C AND CHAPTER 17 SECTION 5 #3(CONDUCT DETRIMENTAL TO THE BEST INTEREST OF RACING) Actions which created a situation where the Pari-Mutuel betting pools were compromised and misrepresented.

**Status as of 7/9/2021 - Subsequent Ruling - As trainer of record on November 7, 2020 of the THE ONLYEST ONE and MISS MEEKO, both of which raced at Scarborough Downs, Mr. Bo Sowers was negligent in not preventing the horses from racing in the wrong races. Mr. Sowers had a duty as sole insurer for the declaration to race his horses, in addition to the strict liability obligation he undertook as trainer, he was negligent in not preventing THE ONLYEST ONE from racing in the 7th race given the relative size differences of the animals, his presence during the post parades, and the performance of MISS MEEKO in the 6th race. As a result of the wrong horses racing in the wrong races, the wagering public suffered losses relying on the entries tendered by Mr. Sowers; Mr. Sowers was not financially advantaged nor is there any evidence of cheating on his behalf. Based on the violation of MSHRC Rule Chapter 7, Section 46, according to the provisions of MSHRC Rule Chapter 1, Section 1, Mr. Sowers is ordered a \$500 fine and 15 day suspension.**
