### **POSITIVE TEST- POST RACE**

Miami Valley Gaming O.S.R.C. 3769-18.01(B)(4)(d) Trainer CHARLIE CONRAD is hereby fined the sum of five hundred dollars (\$500.00) and suspended fifteen (15) days from May 25, 2020 through June 8, 2020 (inclusive) for violation of OSRC Rule 3769-18-.01(B)(4)(d). Blood Sample #872605 tested by the Analytical Toxicology Laboratory at the Ohio Department of Agriculture on March 13, 2020 showed a concentration of TCO<sub>2</sub> at 39.4 +/- 0.8 mpl, which exceeds the O.S.R.C. regulatory threshold of 37.0 mmol/L. In addition, UNCAGED is disqualified from first and placed last. Purse money earned of five thousand dollars (\$5,000.00) in the race must be returned and redistributed. During the period of this suspension Mr. Conrad is denied access to all grounds under the jurisdiction of the O.S.R.C. Furthermore, during the suspension Mr. Conrad may not transfer any horses under his care over to another trainer without permission of the judges or executive director at the OSRC.

**Status as of 8/25/2021 - Subsequent Ruling - Trainer Charles Conrad has dropped his appeal and will serve his fifteen (15) day full suspension from 8/27/21 through 9/10/21. The five hundred dollar (\$500.00) fine and five thousand dollar (\$5,000.00) return of purse needs to be submitted to the judges by 9/11/21. Failure to do so may result in your license being suspended or revoked by the OSRC.**

This is Malone Jr.`s third offense of 2021. Trainer Malone Jr. is fined \$2500, and must forfeit all purse monies. During this suspension, he and all horses trained by him are barred from the grounds, under the jurisdiction of the Maryland Racing Commission.
