#### **POSITIVE TEST- POST RACE**

PA Code Title 7-401.2(a)(1) 401.3(a) 401.3(b) 401.45 401.46 401.41(b) Mr. Tackett was the trainer of the horse MOONWARDS HANOVER for the 1st race on July 11, 2021 at Harrah's Philadelphia. Blood drawn (post race) from MOONWARDS HANOVER was tested and found to contain Tripelennamine. As the trainer, Mr. Tackett is responsible for the positive test. MOONWARDS HANOVER finished 3rd, but has been disqualified. Purse money earned by MOONWARDS HANOVER (\$864) must be returned within ten days of ruling. Mr. Tackett is issued a \$500 fine (fines are due within ten days of ruling) and a fifteen (15) day full suspension (September 25, 2021 up to and including October 9, 2021). Mr. Tackett has waived his hearing and appeal rights. During the time of the suspension all horses owned and/or trained by Mr. Tackett shall also be suspended unless transferred to an owner/trainer in good standing. Any owner/trainer transfers from Mr. Tackett must be approved by the PSHRC.
