### POSITIVE TEST- POST RACE

Travis Alexander was the programmed trainer of MR DS ROCK, 2nd place finisher in the 8th race at the Meadowlands on 1/15/22. The post-race blood sample collected identified the presence of Testosterone at a level greater than the allowable threshold for a gelding in NJAC 13:71-23.16(c). Alexander as trainer of the horse, is the absolute insurer of and responsible for the condition of MR DS ROCK on 1/15/22. Alexander declined his option to have the split sample sent for analysis and waived his right to a hearing before the Board of Judges. The Judges find Alexander in violation of NJAC 13:71-23.1(a)(b); 13:71-23.6(a)(b)(c)(d); and 13:71-23.16(c). As a result, he is hereby suspended for a period of 90 days 2/11/2022 through 5/11/2022, inclusive) and fined the sum of \$2,500. During the suspension, Alexander is denied access to all grounds under the jurisdiction of the NJRC. Consistent with NJAC 13:71-23.7(b), MR DS ROCK is hereby disqualified and the purse ordered redistributed.

### POSITIVE TEST- POST RACE

Trainer Kevin Altig, for being the trainer of record on sample #E443924 taken from ALWAYS A SHARK in the 1st race on January 30th, 2022 at Rosecroft Raceway, was found to contain the drug Tapentadol (Nucynta). Trainer Altig will be issued a 60 day full suspension from February 21st, 2022 through April 21st, 2022. During this suspension, he and all horses trained by him are barred from the grounds, under the jurisdiction of the Maryland Racing Commission. Any transfer of horses during the suspension must be

approved by the judges at Rosecroft Raceway or the Maryland Racing Commission. ALWAYS A SHARK finished 2nd and was placed last. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of ruling. COMAR: 09.10.03.04.B. Six Multiple Medication Violation (MMV) assessed.

**POSITIVE TEST- POST RACE**

Christopher Beaver was the programmed trainer of the horse WESLYNN QUEST when she raced in the 6th race at the Meadowlands Racetrack on May 22, 2021. Following this race, WESLYNN QUEST was required to submit to a post-race blood sample for analysis. A report from Industrial Laboratories identified the presence of Betamethasone. At Mr. Beaver's request, a split sample was analyzed at an approved independent laboratory and did confirm the presence of Betamethasone. This is a direct violation of various rules and regulations of the NJRC. Mr. Beaver waived his right to a hearing with the Board of Judges and accepts the penalty of a full suspension of his NJRC license for a period of 15 days and is also fined the sum of 500.00. Said suspension shall begin on February 4, 2022 and

run through February 18, 2022 inclusive. Consistent with NJAC 13:71-23.7, the horse is hereby disqualified from sharing in the purse from the 6th race on May 22, 2021.

PA Code Title 7-203.22,401.2 A(1),401.41, 205.33, 205.501 (14). Sample #383333 was found to contain Methadone, a Class 1 drug. Sample #383333 was provided by #6 I Saw You Blink, who finished 1st on 01/05/2022 at the Meadows, and was trained by Mr. Goldberg. Thus, #6 is disqualified and placed 8th, the purse (\$4650) is ordered to be returned and redistributed, and Mr. Goldberg, the trainer of record, is fined \$5000 and given a full 180 day suspension. Possible mitigating circumstances have reduced the penalty suggested by the ARCI Guidelines. During his suspension Mr. Goldberg is denied the use and privileges of all the grounds sanctioned by the Pennsylvania SHRC. All horses owned and/or trained by Mr. Goldberg may only be transferred through the judges office at the Meadows. The fine and purse return must be paid within 10 days of this ruling. Mr. Goldberg has 10 days to appeal this decision to the Pennsylvania SHRC, Bureau of Standardbred Racing.

PA Code Title 7-203.22, 401.2 A(1).401.41, 205.33, 205.501 (14). Sample #368362 was found to contain Lamatrigine, a Class 3 drug. Sample was provided by #4 My Friend Kelly, who finished 1st on 8/1/2021 at the Clearfield Fair, and was trained by Mr. Hammer. A request for a split sample also contained Lamitrigine. Thus, #4 is disqualified and unplaced (4 horse field), the purse (\$1350) is ordered to be returned and redistributed (60-30-10%), and Mr. Hammer, trainer of record, is fined \$5000 and given a full 180 day suspension. Possible mitigating circumstances has reduced the penalty suggested by ARCI Guidelines. During his suspension, Mr. Hammer is denied the use and privileges of all the grounds

sanctioned by the PASHRC. All horses owned and/or trainer by Mr. hammer may only be transferred through the Judges office at the Meadows. The fine and purse must be paid within 10 days of this ruling. Mr. Hammer has 10 days to appeal this decision to the PASHRC, Bureau of Standardbred Racing.
