PA Code Title 7-203.22(a) 203.33(b) 401.2(a)(1) 401.2(3)(i) 401.3(a) 401.3(b) 401.45 401.51(a) Mr. Malone was the trainer of the horse RED POWER for the 10th race on 10/5/2021 at Mohegan Sun Pocono. Blood samples taken (post race) from RED POWER were tested and found to contain Fentanyl. As the trainer, Mr. Malone is responsible for the positive test. RED POWER is disqualified and purse money earned (\$8,500) must be returned within 10 days of ruling. Mr. Malone is fined \$10,000 (fines are due within 10 days of ruling) and issued a 365 day full suspension (January 25, 2022 up to and including January 24, 2023). During the time of the suspension, all horses owned and/or trained by Mr. Malone shall also be suspended unless transferred to a trainer in good standing. Any owner/trainer transfers from Mr. Malone must be approved by the PA State Horse Racing Commission.

***Status as of 3/31/2022 - Subsequent Ruling - RULING #22017C The State Horse Racing Commission, Bureau of Standardbred Horse Racing, has received in writing that Appellant, Brian Malone, has withdrawn his appeal of the Harrah's Philadelphia Board of Judges Ruling No. 21107CD, dated 1/14/2022. In consideration of the withdrawal of his appeal, the Commission hereby modifies the suspension as follows: Appellant shall serve a ten (10) day suspension and pay a one thousand (\$1,000.00) dollar fine in this matter. The suspension shall begin on April 1, 2022 and shall continue through April 10, 2022. Fines are due within ten (10) days of ruling. The purse disqualification shall stand. The Commission notes that Appellant demonstrated the existence of mitigating circumstances in this case. PA Code Title 7-401.5, 501.14, 510.15, 501.16 On March 10, 2022 Commission investigators observed trainer Santiago Porfilio administrating an unknown substance to the horse She`sonewriter who was in to go in race 7 on March 10, 2022. The horse was scratched. The unknown substance and a 60cc dose syringe were seized by Commission investigators and sent to PETRL for further testing. Sample #368791 was found to contain Benzoic acid, Bicarbonate, DL-Lactic Acid, Methansulfonic Acid, Palmitic Acid, and Saccharin. Following a hearing conducted in the judges` office at the Meadows on March 24, 2022, Mr. Porfilio is fined \$5,000 and given a full 365-day suspension beginning June 17, 2022 through June 16, 2023. During his suspension, Mr. Porfilio is denied the use and privileges of all the grounds sanctioned by the PASHRC. The fine must be paid within 10 days of this ruling. Mr. Porfilio has 10 days to appeal this decision to the PASHRC, Bureau of Standardbred Racing.
