## CONDUCT DETRIMENTAL TO THE BEST INTEREST OF HORSE RACING

RULING #22016C On March 4, 2022, the Pennsylvania State Horse Racing Commission, Bureau of Standardbred Horse Racing received an application from Mr. Robert E. Belcher for an owner-trainer license. Upon review of Mr. Belcher's prior history of racing violations, the application for an occupational license is hereby denied. In accordance with Section 9323 of the Race Horse Industry Reform Act, the licensee's previous conduct and corrupt actions are a threat to the public interest, the effective regulation and control of horse racing and to the health, safety and welfare of the racing participant and the racehorse. Mr. Belcher's presence is detrimental to the best interest of racing. In accordance with 7 Pa. Code Chapter 185, an occupational license is granted upon the express condition that the licensee shall accept, observe and abide by rules and regulations of the Commission. In addition, Mr. Belcher is denied a license in accordance with and under a reciprocal licensing action
