# CONDUCT DETRIMENTAL TO THE BEST INTEREST OF HORSE RACING

PA Code Title 7-401.5, 501.14, 510.15, 501.16 On March 10, 2022 Commission investigators observed trainer Santiago Porfilio administrating an unknown substance to the horse She`sonehotwriter who was in to go in race 7 on March 10, 2022. The horse was scratched. The unknown substance and a 60cc dose syringe were seized by Commission investigators and sent to PETRL for further testing. Sample #368791 was found to contain Benzoic acid, Bicarbonate, DL-Lactic Acid, Methansulfonic Acid, Palmitic Acid, and Saccharin. Following a hearing conducted in the judges` office at the Meadows on March 24, 2022, Mr. Porfilio is fined \$5,000 and given a full 365-day suspension beginning June 17, 2022 through June 16, 2023. During his suspension, Mr. Porfilio is denied the use and privileges of all the grounds sanctioned by the PASHRC. The fine must be paid within 10 days of this ruling. Mr. Porfilio has 10 days to appeal this decision to the PASHRC, Bureau of Standardbred Racing.

Status as of 4/8/2022 - Stay - RULING#22019c On March 31, 2022, The State Horse Racing Commission, Bureau of Standardbred Horse Racing, received correspondence from licensed trainer Santiago N.
