LOW OR EXCESS LEVEL OF AUTHORIZED MEDICATION

Blood sample #901822 collected at Miami Valley Gaming on 4/25/2022 from the horse MIGRATE BLUE CHIP was found to contain flunixin at a concentration of 341 +/- 34 nanograms per milliliter of plasma. This exceeds the Regulatory Threshold of 20 nanograms per milliliter adopted by the OSRC. Trainer Michael Arnold has been issued a warning. O.S.R.C.-3769-18-01(B)(18)(a).

POSITIVE TEST- POST RACE

As a result of the administrative hearing conducted on May 19, 2022, the Board of Judges has determined that: NJRC licensee, Matthew Aubin was the programmed trainer of the horse "Hypothetical" when it finished second in the 6th race at Freehold Raceway on Saturday, February 26, 2022; The blood sample collected from the horse identified the presence of the prohibited substance N-Ethylnicotinamide, a Class 1 performance enhancing drug which is in direct violation of NJRC rule 13:71-23.1. As such, Mr. Aubin is suspended for a period of one-year, Friday, July 1, 2023 through and including Friday, June 30, 2024 and is also fined the sum of \$5,000.00 dollars. Payment of the fine associated with this ruling must be received by the NJRC on or before June 30, 2024. Consistent with N.J.A.C. 13:71-23.7, Hypothetical is hereby disqualified from sharing in the purse from the 6th race on Friday, February 26, 2022. The purse is hereby ordered to be redistributed among the remaining finishers.

As a result of the administrative hearing conducted on May 19, 2022, the Board of Judges has determined that: NJRC licensee, Matthew Aubin was the programmed trainer of the horse Brooklynite when it competed and finished 1st in the 4th race at Freehold Raceway on Friday, March 4, 2022; The blood sample collected identified the presence of the prohibited substance N-EthylNicotinamide, a Class 1 performance enhancing drug; As a result of the positive post-race blood analysis, Mr. Aubin is in violation of NJRC rules and is suspended for a period of one-year, Friday, July 1, 2022 through and including Friday, June 30, 2023 and fined the sum of \$5,000.00 dollars. Payment of the fine associated with this ruling must be received by the NJRC on or before June 30, 2023. Consistent with NJRC 13:71-23.7, Brooklynite is hereby disqualified from sharing in the purse from the 4th race on Friday, March 4, 2022. The purse is hereby ordered to be redistributed among the remaining finishers.

POSITIVE TEST- POST RACE

Williams Hernandez was the programmed trainer of the horse "Big Smoove" when he raced in the 2nd race at Freehold Raceway on April 24, 2021. Following this race, "Big Smoove" was required to submit a blood sample for analysis. A report from Industrial Laboratories identified the presence of Flunixin above the allowable limits. As a result, Mr. Hernandez is issued a full suspension of his NJRC license for a period of 15 days and fined the sum of 500.00 dollars. Said suspension shall begin on June 10, 2022 and run through June 29, 2022, inclusive. During the period of suspension, Mr. Hernandez is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. The fine associated with this ruling must be paid on or before June 29, 2022.

Consistent with N.J.A.C. 13:71-23.7, the horse "Big Smoove" is disqualified from sharing in all purse monies earned on April 24, 2021. For full ruling, contact NJRC.

Status as of 6/10/2022 - Stay - NJRC is in receipt of a notice of appeal and request for a stay from Williams Hernandez in connection with a 20-day suspension, \$750 fine, disqualification of the horse BIG SMOOVE, loss of purse and 1/2 MMV point issued by the Board of Judges at Freehold Raceway in connection with a post-race positive test results revealing the presence of Flunixin in the horse BIG SMOOVE after the 2nd race on April 24, 2021. The Executive Director hereby grants a stay of the penalties pending a final determination by the NJRC.

71 IAC 5-3-2(a)(2), 71 IAC 8-1-2(a), 71 IAC 8-1-4.2(3) Sample #520213 collected from BLUEBIRD YOSHI in the 7th race on 5/18/2022 was found to contain "Betamethasone" at 34.2 pg/mL which is over the allowable limit of 10 pg/mL.
