#### POSITIVE TEST- POST RACE

OSRC 3769-18-01-B(1,10,13,15,16),18-02,17-43. Urine sample #906071 was tested by the OH Dept. Of Ag. ATL and found to contain 3-METHOXYTYRAMINE (3-MT), a Class 2 drug, at a concentration level of 7.2 mcg/ml of urine. This exceeds the Regulatory Threshold of 4.0 mcg/ml, adopted by OSRC for 3-MT. Sample #9606071 was collected from #4 Grand Ole Party, who finished 1st in race 16 on 7/27/22 at Scioto Downs and was trained by Ms. Binkley. Thus #4 is disqualified and placed 10th, the purse (\$6000) ordered returned and redistributed; Ms. Binkley is fined \$1000, given a full one year suspension (9/3/22-9/2/23) and referred to OSRC for any further recommendations. During her suspension, Ms. Binkley is denied the use and privileges of all grounds sanctioned by OSRC. All horses owned/trained by Ms. Binkley may only be transferred by the judges at Scioto Downs or OSRC. The fine and purse must be returned within 10 days of this ruling. Ms. Binkley has 48 hours to appeal this decision to the OSRC.

#### IMPROPER CONDUCT OR LANGUAGE TO AN OFFICIAL

Owner Cary Doehring is hereby issued a summary suspension effective 7/24/2022 pending a stewards` hearing. Mr. Doehring engaged in abusive behavior, both verbal and physical, toward all three Hawthorne stewards after the races on July 23, 2022, when he followed the stewards into their office uninvited. His aggressive and abusive conduct continued into the clubhouse entryway and ultimately the parking lot as the stewards were attempting to leave for the evening.

Status as of 9/1/2022 - Subsequent Ruling - Owner Cary Doehring is hereby issued a full suspension, effective 9/1/22 through 12/31/23, and a civil penalty of \$2000 payable within 30 days of 9/1/22, the result of a stewards' hearing held on 8/18/22 at the Springfield State Fair regarding abusive behavior and improper conducted towards the stewards on 7/23/22 at Hawthorne. These charges were addressed in Ruling #1081 resulting in a summary suspension issued on 7/24/22. This new ruling supersedes #1081. During the suspension, Doehring is barred from all facilities under the jurisdiction of the IRB. Under USTA rules he is disallowed any participation at any county or state fairground where racing is conducted under USTA rules. Doehring has relinquished ownership of all horses currently racing in IL and remains ineligible to own wholly or in part any horse through 12/31/23 that participates in IL racing. At the conclusion of the suspension he will be subject to a stewards' review before licensing will be reconsidered. IRB rule #1320.

Sample #906060 was collected from #4 Milford`s Z Tam, who finished 1st in race 5 on 7/27/22 at Scioto Downs and was trained by Mr. Hitchcock. Thus, #4 is disqualified and placed 10th, the purse (\$4250) is ordered returned and redistributed, and

Mr. Hitchcock is fined \$500 and given a full 15 day suspension (09/03/2022-09/17/2022). During his suspension, Mr. Hitchcock is denied the use and privileges of all the grounds sanctioned by the OSRC. All horses owned and/or trained by Mr. Hitchcock may only be transferred through the judges office at Scioto Downs or by the OSRC. The fine and purse must be paid within 10 days of this ruling.
