POSITIVE TEST- POST RACE

Sample #E542868 collected from STELLA ROSE following the seventh (7th) race on August 17, 2022, was found to contain "RACTOPAMINE" which is a Drug Class 2, Penalty Class A, violation. The standard penalty is a minimum one (1) year suspension, a fine of \$5,000, and six (6) Multiple Medical Violation (MMV) points absent mitigating circumstances, in addition to a loss of purse. After notification of the positive, Mr. Hooley brought in proof from the feed company that contamination of his feed came from a batch that contained "OPTAFLEX (Ractopamine hydrochloride)" for cattle that was mixed just prior to his batch. It was confirmed by the feed company that Mr. Hooley's feed mixture has never had "RACTOPAMINE" added to it. After reviewing the evidence, the Judges find that Mr. Hooley was not culpable for the contamination. Therefore, the penalty is mitigated to "Loss of Purse". STELLA ROSE finished first (1st) is disqualified. Winner's share \$33,000, to be returned and redistributed. See 71 **HoP** on 8/25/2022

HORSE DISQUALIFIED - PLACED 8, PURSE REDISTRIBUTION

POSITIVE TEST- POST RACE

Sample #E542976 collected from COACHES CORNER following the eighth (8th) race on August 25, 2022, was found to contain "RACTOPAMINE" which is a Drug Class 2, Penalty Class A, violation. The standard penalty is a minimum one (1) year suspension, a fine of \$5,000, and six (6) Multiple Medical Violation (MMV) points absent mitigating circumstances, in addition to a loss of purse. After notification of the positive, Mr. Hooley brought in proof from the feed company that contamination of his feed came from a batch that contained "OPTAFLEX (Ractopamine hydrochloride)" for cattle that was mixed just prior to his batch. It was confirmed by the feed company that Mr. Hooley's feed mixture has never had "RACTOPAMINE" added to it. After reviewing the evidence, the Judges find that Mr. Hooley was not culpable for the contamination. Therefore, the penalty is mitigated to "Loss of Purse". COACHES CORNER finished first (1st) is disqualified. Winner's share \$3,750, to be returned and redistributed. See

On 10/03/2022 a hearing was conducted and as a result of the facts and findings trainer Paul McHugh is hereby suspended in full for a period of 90 days, beginning 10/05/2022 through and including 01/02/2023. During this time Mr. McHugh is barred from all access to the grounds of Plainridge Park Race Course and Casino.
