OSRC-3769-18-01-B(1,4,10,13,15),18-02,17-43. Blood sample #906424 was tested by the Ohio Department of Agriculture ATL and was found to contain furosemide at a concentration level of 168 nanograms per milliliter of plasma, which exceeds the regulatory threshold of 100 nanograms per milliliter adopted by the OSRC for furosemide in plasma. Sample #906424 was collected from #5 Always A Z Tam, who finished 1st in race 8 on 8/26/22 at Scioto Downs, and was trained by Jeff Brewer. Therefore, #5 is disqualified and placed 9th, Mr. Brewer is fined \$500 and the purse (\$5000) is ordered returned to Scioto Downs and redistributed. The fine and purse must be paid within 10 days of this ruling. Mr. Brewer has 48 hours to appeal this decision to the OSRC.
