### **POSITIVE TEST- POST RACE**

OSRC-3769-18-01-B(1,10,13,15,16). 18-02, 17-43. Blood sample #906247 was tested by the Ohio Dept. of Agriculture ATL and was found to contain, Caffeine, a Class 2 drug, at a concentration level of 1612 nanograms per milliliter of plasma, which exceeds the regulatory threshold of 100 nanograms per milliliter of plasma, that was adopted by the OSRC. Sample #906247 was collected from #4 Annie Way Possible, who finished 1st in race 12 on 8/10/22 at Scioto Downs, and was trained by Mr. Galliers. Thus, #4 is disqualified and placed 8th, the purse (\$6000) is ordered returned and redistributed, Mr. Galliers is fined \$1000, and given a full 30 day suspension (2nd offense in 365 days) from 9/18/2022-10/17/2022. During his suspension, Mr. Galliers is denied the use and privileges of all the grounds sanctioned by the OSRC. All horses owned and/or trained by Mr. Galliers may only be transferred through the Judges office at Scioto Downs or by the OSRC. The fine and purse must be paid within 10 days

Status as of 11/26/2022 - Subsequent Ruling - Mr. Galliers has withdrawn his appeal of ruling 22-DAY-110 and will serve his 30 day full suspension from December 2 through December 31, 2022. During his suspension, Mr. Galliers is denied the use and privileges of all the grounds sanctioned by the OSRC. Mr. York waived his right to request a split sample. A hearing was conducted in the judges' office at the Meadows on September 8, 2022 resulting in the following penalties: No. 3 GITCHYGITCHYGOO is disqualified from all purse monies and placed last, the purse money (\$1,350.00) from that race is ordered to be returned and redistributed. Mr. York, trainer of record, is fined \$1000.00 and issued a 15-day full suspension beginning September 26, 2022 through October 10, 2022 (inclusive).
