### POSITIVE TEST- POST RACE

Blood sample #902567 collected at the Darke County Fair on 8/25/22 from the horse Hustlenomics was found to contain betamethasone at a concentration of 23+-6 picograms per milliliter of plasma. This exceeds the Regulatory Threshold of 10 picograms per milliliter adopted by the OSRC. All purse money must be returned for redistribution (\$4,412.00). O.S.R.C.-3769-18-01(B)(10)&(13) 18-02 18-99 If the fine is not paid to the judges by 10/21/22 you shall be suspended. During his suspension Mr. Luther is barred from all grounds governed by the OSRC. Any horses under his care that he wants to transfer to another owner or trainer must be approved by the judges or the OSRC.

Status as of 12/22/2022 - Subsequent Ruling - Mr. Luther has withdrawn his appeal of ruling 22Grnvlle1 at the Dark County Fair and the penalty has been amended. All purse money must be returned for redistribution (\$4,412.00). O.S.R.C.-3769-18-01(B)(10)&(13) 18-02 18-99 If the fine is not paid to the judges by 1/1/23 he shall be suspended. During his suspension Mr. Luther is barred from all grounds governed by the OSRC. Any horses under his care that he wants to transfer to another owner or trainer must be approved by the judges. If the purse money is not returned by 1/1/23 the owner shall stand suspended until all purse money has been returned to the permit holder. Horse owned wholly or in part by the owner shall also be suspended and are not transferable until the purse money has been returned.

# FAILURE TO PAY FINE(S)

USTA Rule 22.00 S22.01. The Massachusetts license No.26115 of Trainer Justin Sodano, is herby suspended indefinitely for failure to pay a previous fine for a bounced check for licenses on 10/28/2022, Ruling No.0189-22. This is a Full Suspension. Previously Mr. Sodano's was suspended on 11/21/2022, Ruling 0191-22 and subsequently reinstated by the Judges at Plainridge Park Race Course on 11/25/2022, Ruling No.0194-22. The Judges spoke to Mr. Sodano by phone on 11/25/2022 at which time Mr. Sodano acknowledged the bounced check and fees and agreed to immediately make payment by mailing a check. Based on that conversation with Mr. Sodano the Judges extended a courtesy and agreed to reinstate his license with the understanding that the check would be mailed immediately. Thirty two days have passed and such no payment has been received. As a result the Judges are taking this action. Mr.Sodano's license will NOT be reinstated until such time that payment has been received.
