DHRC Licensee Ricky Taylor, having waved his right to a Judges hearing, is now under a 30 day Full suspension (1/17/2023 through and including 2/15/2023) for failing a human drug test. Mr. Taylor tested positive for Cocaine (See DHRC rule: 5.1.8.5.2). Following his completed suspension, Mr. Taylor, in accordance with DHRC rules: 5.1.8.5.5 and 5.1.8.5.6, will be subject to enhanced testing at his expense. Mr. Taylor is responsible for the cost of the failed test (\$32.00).
